Terms and Conditions

Entry

- The prize draw is free to enter and no investment in Witan Investment Trust plc (directly or indirectly) is required. By entering the prize draw you agree to be bound by these terms and conditions.
- Entry is open to residents of the United Kingdom except to staff (and their immediate family members) of Witan Investment Trust plc, Witan Investment Services Limited, connected printers and agents, the suppliers of the prize and any other third parties associated with the prize draw.

Prize
